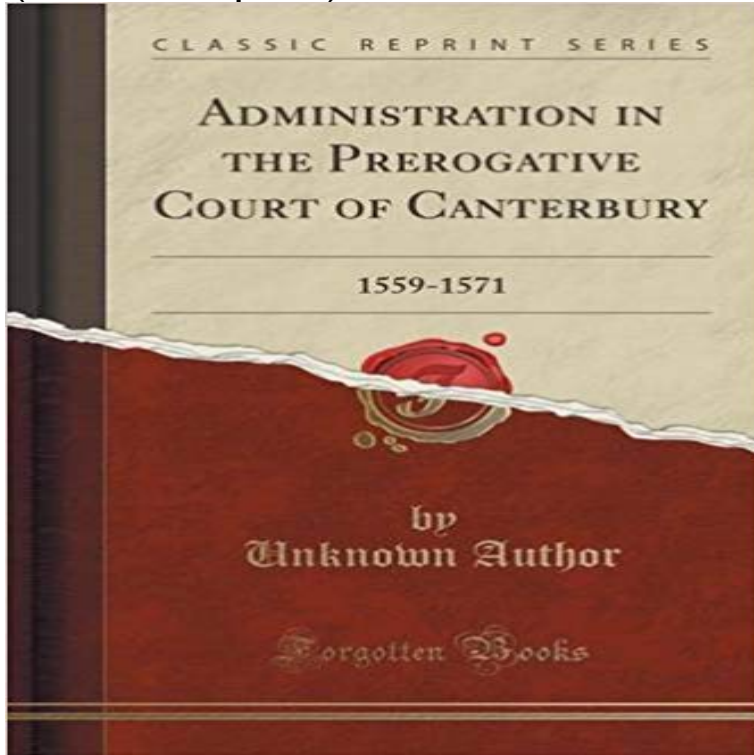

The Administration Acts appear in similar form to the foregoing. Henceforward they are extracted and not given in full. The place names have been given for the sake of convenience in their modern forms and spelling, whenever this has been found possible. The words in brackets, in ordinary type, after the habitations of the deceased persons refer in all cases to the diocese in which they were, at that date, included. The names of counties in italics are inserted by myself, and are therefore subject to mistakes.
