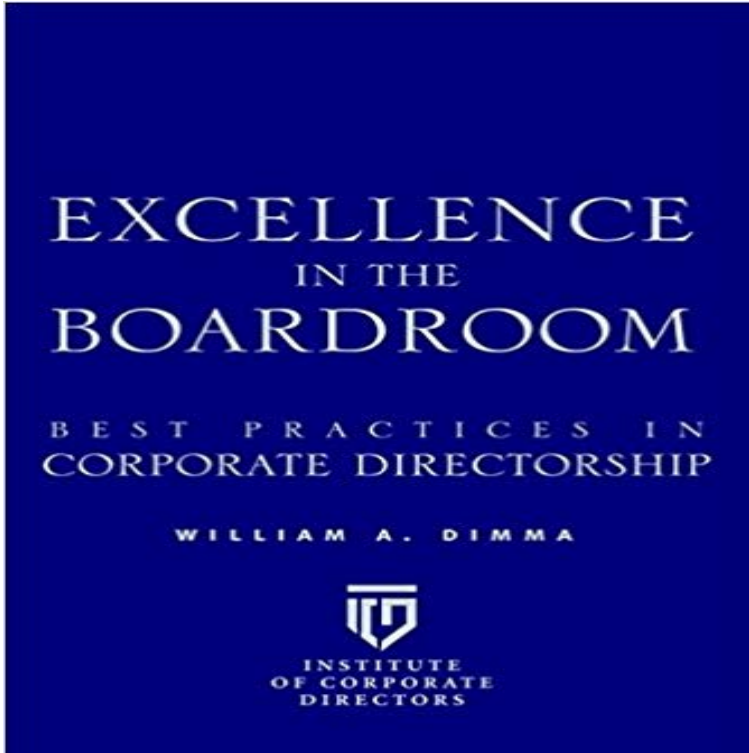


Excellence in the Boardroom: Best Practices in Corporate Directorship
