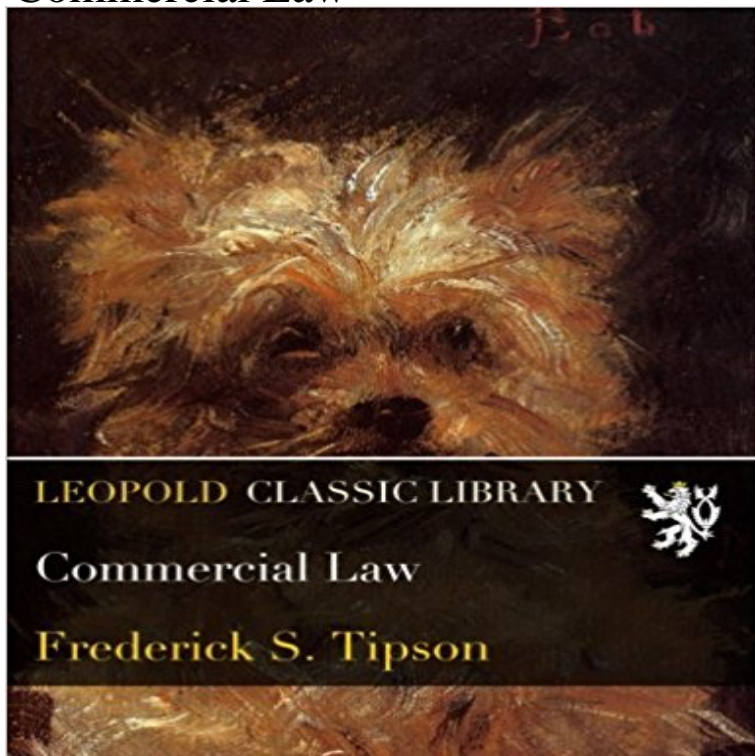


## Commercial Law
