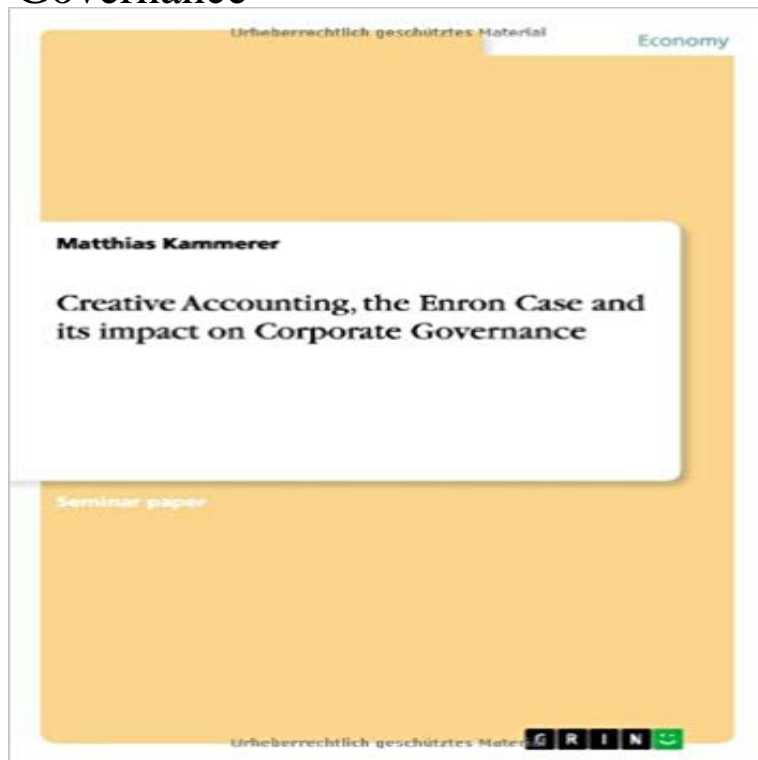


# Creative Accounting, the Enron Case and its impact on Corporate Governance
