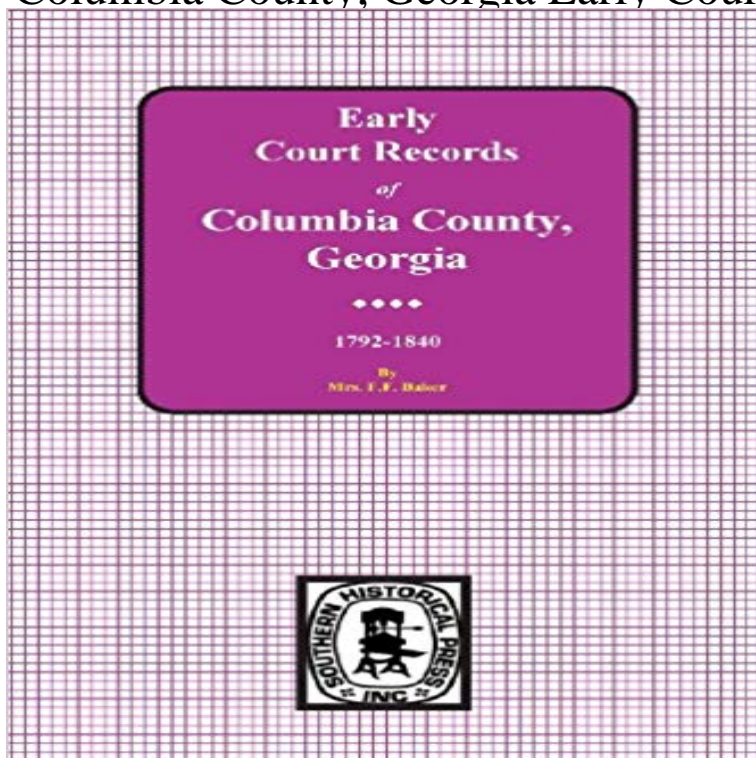


Columbia County, Georgia Early Court Records, 1792-1840
